Call for papers / proposals: "Entrepreneurship Process Research"

After the worst of the covid-19 pandemic seems to be over, we resume our series of seminars with the 5<sup>th</sup> edition of the **Paper Development Seminar** (**5PDS**). Our aim (sanitary conditions permitting) is to hold this seminar in person at the University of Seville, Seville (Spain).

Papers / proposals applying a process perspective to entrepreneurship are welcome. We are open to any contributions analysing the entrepreneurial process, may they be conceptual or empirical and, in this latter case, using quantitative (ideally longitudinal, but also cross-sectional) and/or qualitative methods.

Submissions will be peer reviewed. Those deemed of highest potential by the organizing committee will be invited to participate. Selected participants will be offered the opportunity to submit a full paper (if they did not do so initially). Extended abstracts may also be presented at the seminar. The objective is to develop a productive and intimate work environment. For this reason, we will limit the number of proposals/papers to be accepted into the seminar to a maximum of 20.

Robert Blackburn is Professor at the University of Liverpool. He is appointed Chair of the sub-panel Unit of Assessment 17 (Business and Management) in the Research Excellence Framework (REF 2021). Prof. Blackburn is the Editor-in-Chief of the *International Small Business Journal: Researching Entrepreneurship*, Treasurer of the Society of the Advancement of Management Studies (SAMS) and have served as expert in the REF-2014 and REF-2021.



**Marco van Gelderen** focuses his research as well as his teaching activities on individual level enterprising competencies. ## **Submission instructions**

The deadline for the **submission of papers** / **proposals is January 22<sup>nd</sup>**, **2022.** There is no specific format or template to follow. However, in the case of proposals, a minimum of 1500 words is required, including aims, theoretical framework, methodology and findings (if applicable), implications and contribution. The proposals will be evaluated by the organizing committee with the help of external reviewers, if needed. On **February 7**<sup>th</sup>, **2022**, **decision letters** will be sent to submitting authors.

Authors of the accepted papers / proposals are encouraged to submit a **more developed version by March 31**st, **2022**, although this is not required. The papers/proposals will be presented orally by the authors in the allocated time, followed by some time for Q&A.

All submissions will be presented to the audience and the invited speakers. The authors will receive general comments, specific clarifications and suggestions from the academics that make up the panel of experts in entrepreneurship. This highly qualified feedback will allow authors to improve their manuscripts in order to getting published in top academic journals in the field of entrepreneurship.

### Registration

Thanks to the generous support of the ECSB, the registration fee can be kept to the moderate rate of 150€ per participant. Information on how to register and pay will be provided to the authors of accepted papers/proposals at the end of January 2022.
